- I will provide proper and sufficient food, water, shelter, and humane treatment to the pet at all times. I further agree the dog will not be chained at any time as a means of restraint or punishment or be primarily an outside dog. _____ (initials)
- *PuppyPromise Rescue* cannot predict the actions of adopted pets. I agree to give my new pet **sufficient and reasonable** time to acclimate to its new surroundings, new family, and important areas. _____ (initials)
- Although an animal may appear healthy when adopted, unforeseen exposure resulting in illness or congenital defects may not have been detected. I understand that it is my responsibility, as the new owner, to pay for fees incurred for any unforeseen veterinary charges. _____ (initials)
- I will keep a collar and identification tag on the dog at all times and will license the dog with the county/city. _____ (initials)
- I agree to immediately notify *PuppyPromise Rescue* if the pet is lost or stolen. I further agree, in the event the animal is lost, that I will make any reasonable effort to locate and claim the animal. _____ (initials)
- I agree to provide all the necessary vaccinations as advised by the pet's veterinarian. When the pet becomes sick or injured, immediate medical care shall be provided, and I shall take full responsibility for the veterinary expenses. _____(initials)
- Under no circumstances shall the pet be intentionally harmed, neglected, nor abused physically and emotionally. _____ (initials)

- If the Adopter wishes to return the pet, must provide prior written notice to *PuppyPromise Rescue*. After the approval form, the Adopter shall make necessary arrangements for a return. Until the pet is returned to *PuppyPromise Rescue*, the Adopter is responsible for providing proper care. _____ (initials)
- The Adopter agrees to indemnify and hold *PuppyPromise Rescue* harmless for any injury, illness, amputation, scarring, death, damages, or other losses to the pet, arising out of the Adopter's negligence or liability. _____ (initials)
